INTRODUCTION

Welcome to Intensive Reading for Retakers. This year we will be focusing on becoming better readers along with improving reading comprehension and vocabulary development as a means of helping you pass one of the following assessments:

Grade 12: FSA ELA, FAST, ACT English and Reading, or SAT Language Arts and Reading **Grade 11:** FAST, ACT English and Reading, or SAT Language Arts and Reading

This is a graduation requirement to receive a high school diploma.

COURSE OBJECTIVES

This class aims to prepare students for the Florida State ELA Tests, as well as the strategies needed for the Reading components of the ACT and SAT which are national tests. The following topics will be covered:

Literature:

- Story Details, Summarize and Point of View
- Analyzing Elements of Fiction
- Understanding Poetry and Drama
- Identifying Comparisons/Contrast

Informational Text:

- Main Idea, Supporting Details and Summary
- Relationship between events
- Inferencing
- Vocabulary

Text Structures

- Primary and Secondary Sources
- · Opinion and Evidence
- Charts, Diagrams and Timelines
- Comparison and Contrast

Writing:

- Informational Text
- Developing claims and arguments

MATERIALS

- Composition Notebook
- Binder with lined paper (College or Wide-Rule)
- Pens/Pencils, Red Pen, Highlighter (any color), and Pencil Sharpener
- Flash Drive
- Laptop computer (if possible)

HOMEWORK

Students are assigned home-learning activities throughout the week. Reading, review, and test preparations are all considered home-learning.

Grades are based on the Miami-Dade County Grading Scale.

CLASSROOM RULES

Make-Ups:

- Late work will not be accepted, unless authorized by the teacher. If work is not turned in on the day it is due the student will receive a **Z** for that assignment.
- If the teacher authorized the student to turn in work late, the grade received will be no higher than a B on the assignment if turned in on authorized due date. If the student does not turn in work on the authorized due date, the grade will be a Z for that assignment.
- If the student has an excused absence, it is his or her responsibility to find out what work was missed from a peer or from the teacher. The student will then have the next class to complete the work.

Cheating:

Cheating is completely UNACCEPTABLE if a student is caught cheating, they will receive a **Z**, a call home will be made, and administration will be notified. Plagiarism is considered cheating, if/when caught the cheating procedures will apply.

Florida State ELA Graduation Requirements 2023-24

According to Florida law, students must meet certain academic requirements to earn a standard high school diploma from a public school. This means that students must pass required courses, earn a minimum number of credits, earn a minimum grade point average, and pass the required statewide assessments.

Students who meet these requirements but do not pass the required assessments will receive a certificate of completion, which is not equivalent to a standard high school diploma. Passing scores for the statewide assessments are determined by the State Board of Education (SBE).

Beginning in 2023–24, students who need to meet the grade 10 ELA assessment graduation requirement will be able to participate in **either** the FSA ELA Retake or the FAST ELA Reading Retake. They may not take both in the same testing window.

Concordant Testing

A student can meet assessment graduation requirements by earning the required statewide, standardized assessment score or a concordant or comparative score.

Concordant tests include the ACT and the SAT.

Students who have a lunch free-or-reduced status are entitled to 2 fee registration waivers for taking their ACT and 2 fee registration waivers for taking their SAT which they can acquire from their school counselor.

^{*}For the ACT English and Reading subtests, if the average of the two subject test scores results in a decimal of 0.5, the scores shall be rounded up to the next whole number.

In addition to the national testing listed on the next page, two Non-College reportable (NCR with extended time) ACT and SAT tests will be scheduled at the school site, one of each in fall 2023 and one of each in the spring of 2024 for 11th and 12th grade Reading Retakers.

^{*}The scores for the English and Reading subject test on the ACT are not required to come from the same test administration.

For the ACT, accommodations are allowed for both ESOL students and students with disabilities. These accommodations must be requested through online registration and verified by your school counselor.
